

We at Bargain Car Rentals recognise the importance of protecting your personal information. This privacy notice explains how the Bargain Car Rentals Group protects your privacy and summarises how it collects, uses and discloses personal information about you.

We are bound to comply with the National Privacy Principles in Australia's Privacy Act 1988 (Privacy Act) and other laws which protect your privacy. The National Privacy Principles regulate the handling of personal information about individuals by private sector organisations. We sometimes handle personal information relying on exemptions under these laws (for example in relation to employee records and transfer of information between our related bodies corporate), and this Privacy Policy may not always apply in those circumstances.

This notice does not apply to our handling of personal information about staff and job applicants. Please contact us if you would like further detail about how we handle that information.

In this notice we also explain how you can contact us if you have a query about any personal information that Bargain Car Rentals may be holding about you.

We recommend that you take the time to read this privacy notice and retain it for future reference.

About the Bargain Car Rentals System "Bargain Car Rentals" is the trading name of JBM (tas) PTY LTD ABN 34 115 153 930 .

What personal information does Bargain Car Rentals collect about me and how does it collect it? When you rent a vehicle from Bargain Car Rentals, we need to collect certain information from you. The service you use will determine what information we collect from you. That information may include your:

- name;
- address;
- contact telephone number(s);
- contact facsimile number(s);
- date of birth;
- driver's licence number;
- car preference;
- debit or credit card number and expiry date;
- e-mail address;

In certain circumstances, we may collect sensitive information about you. For example, we may collect information about your membership of a professional association in order to provide you with the correct discount for our services. Sensitive information under the Privacy Act includes information about an individual's membership of a professional or trade association. We will only collect sensitive information about you with your consent or otherwise in accordance with the law. We will also record information about where you collected the car and the date, time and location of its return.

How we collect the information will depend on how you use our services. We may collect information directly from you by telephone, fax, e-mail, over the counter, or through our Internet based service. We may also collect information about you indirectly through a travel agent or wholesale aggregator and alike.

You can choose not to provide some of your personal details but this may prevent us from providing our services to you or limit our ability to provide you with the level of service that you would normally expect from us.

How is my personal information used or disclosed by Bargain Car Rentals?

We strive to ensure a stress-free rental experience and we are dedicated to building a rewarding and lasting relationship with every customer. In order to provide the level of service we believe you expect from us, we may use and disclose your personal information to:

- provide the services that you request;
- do all things necessary to administer those services;
- research, develop, manage, protect and improve our services;
- conduct customer satisfaction surveys and inform you of any improvements that we have made to our services; and
- maintain and develop our software and other business systems.
- We may disclose your personal information to third parties including:
 - other members of the Bargain Car Rentals Group;
 - your company or organisation if you use our services under a corporate account;
 - our contracted service providers (including our after hours emergency support);
 - debit and credit card providers;
 - banks;
 - credit reporting and fraud checking agencies;
 - debt collection agencies, if you default in payment of monies owed to us;
 - councils, government and private organisations responsible for the processing or handling of traffic related infringements;
 - in relation to an accident or claim, insurers, the police and other persons involved in the accident or claim;
 - driver licensing authorities; and
 - government, regulatory and law enforcement agencies where the disclosure is required or authorised by law.

Use or disclosure for direct marketing purposes We may use and disclose your personal information to offer you products and services provided by the Bargain Car Rentals Group.

We may continue to provide these offers to you by email, telephone, fax or any other form of communication until you opt out. You can opt out by indicating your preference on the rental document or by contacting us (see "Who can I contact for further information?", below).

How Bargain Car Rentals protect my information? We take reasonable steps to protect personal information from misuse and loss and from unauthorised access, modification or disclosure. This protection applies in relation to information stored in both electronic and hard copy form.

You should note that no data transmission over the Internet can be guaranteed to be 100% secure. Accordingly, if you use our website www.bargaincarrentals.com.au to submit any personal information to us, we cannot ensure or warrant the security of any information sent to us in this way. This is also true for information sent to us via email. Bargain Car Rentals has no way of protecting that information until it reaches us. Once we receive your personal information by email, we are required to protect its security in accordance with privacy laws.

Tell us if we need to update your personal information or preferences If you believe that any of the information that we hold about you is not current or incomplete,
